The cross-sectoral strategy affirms the central role of human rights in German development policy and contains binding requirements for the implementing agencies; the Guidelines provide guidance on the incorporation of human rights standards and principles, including gender, in programme proposals.

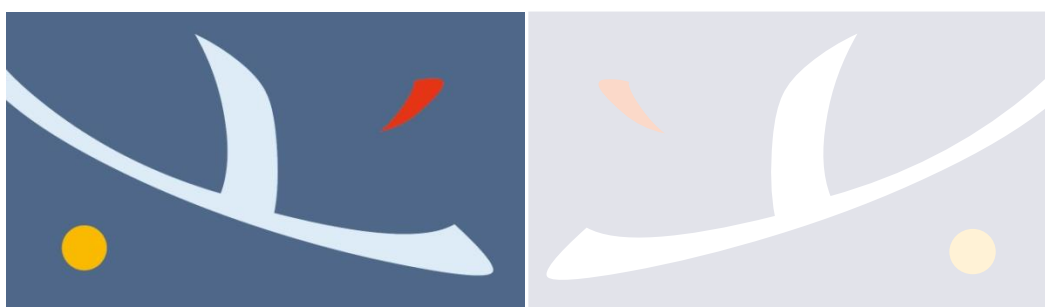
UN Committee on Economic, Social and Cultural Rights (CESCR), General Comment No. 13 on ICESCR Article 13: the right to education (E/C.12/1999/10, 1999)

The treaty bodies, committees of independent experts established under the UN human rights treaties, issue “General Comments”, authoritative interpretations of the provisions of the treaty. The CESCR, through General Comment No. 13, has interpreted Article 13 with respect to the right to education, defining the following core elements of the right: availability, accessibility, acceptability and adaptability.

All states parties are obliged to submit regular reports to the CESCR on the steps taken to implement the rights stipulated by the Covenant. The Committee examines each report and addresses its concerns and recommendations to the state party in the form of “Concluding Observations”.

He carries out country visits and issues annual reports, which focus on specific issues related to the right to education, such as the right to education of girls or education in emergency situations.

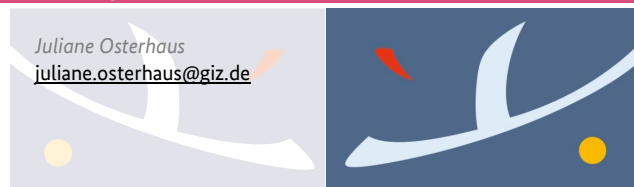
